RECP officials attributed the increase in average time required to process claims to differing characteristics associated with each claim and the different factors involved in the review and application of the RECA legislation, as amended, for the five claims categories. RECP officials told us that since the inception of the program, its policy has been to assist claimants in any way that it can. For example, rather than denying a claim for a lack of documentation, program officials said that they allow claimants additional time to provide corroborating documentation. In many cases, claimants in the uranium industry were employed as millers, miners, and ore transporters over the course of their career. RECP officials said that if a claimant filed a uranium miner claim, but could not provide sufficient documentation to satisfy RECA's uranium miner requirements, RECP would work with the claimant to obtain additional documentation in order to satisfy the uranium miller or transporter requirements where appropriate. RECP officials cited other reasons for delays in processing claims, including RECPs need, in certain cases, to gather medical records to address RECA's...
